

SEVEN HILLS RACING

Waiver Form and Membership Application (mandatory) rev. 1/16/06

In consideration of the acceptance of my application for membership in Seven Hills Racing, a bicycle racing team (hereafter "Team"), I hereby freely agree to and make the following contractual representations and agreements.

By this instrument I hereby release Seven Hills Racing and the Cincinnati Cycle Club, any and all volunteers, and all other persons, sponsors and organizations involved in races and activities of Seven Hills Racing. I recognize and acknowledge that bicycling is a rigorous activity that may be stressful and may aggravate existing physical or mental conditions or cause new ones. I understand that such activity can be dangerous and that the dangers may include damage to or destruction of personal property, serious physical injury or even death. I represent that:

- 1. I am 18 years of age or older (if under 18, you must include an authorized signature of parent or legal guardian);***
- 2. I am submitting this release, waiver of liability, and assumption of risk declaration voluntarily and of my own free will;***
- 3. I have had no physical or emotional problems, nor any history thereof, that will impair my ability to participate in the training or event(s);***
- 4. I understand that race and training conditions may be on traffic-maintained public roads, presenting serious and, in some cases, unavoidable risk and I acknowledge that, while event organizers may undertake emergency assistance activities, they are under no obligation to do so. I also understand that in any event, emergency assistance may be unavailable or impossible. I understand that it is my responsibility to assess the hazards presented, and the ultimate determination as to whether to bicycle on any given day is to be made in my sole judgment on the basis of my own inspection of the course, road, or facility.***

I acknowledge that bicycling is an inherently dangerous sport and fully realize the dangers of participating in a bicycling racing team and FULLY ASSUME THE RISKS ASSOCIATED WITH SUCH PARTICIPATION INCLUDING by way of example and not limitation, the following: the danger of collision with pedestrians, vehicles, other riders, and fixed or moving objects; the dangers arising from surface hazards, equipment failure, inadequate safety equipment, weather conditions, and THE RELEASED PARTIES' OWN NEGLIGENCE; and the possibility of property loss, and serious physical and/or mental trauma or injury associated with bicycling and related activities.

For myself, my heirs, executors, administrators, legal representatives, assignees, and successors

in interest (collectively "Successors") I HEREBY WAIVE, RELEASE, DISCHARGE, HOLD HARMLESS, PROMISE NOT TO SUE AND INDEMNIFY the following entities or persons: Seven Hills Racing Team and it's directors, officers, sponsors, Team members, employees, volunteers, representatives, agents, contractors, the event holders, event sponsors, event directors, event volunteers, and their successors, assigns and insurers (collectively the "Released Parties") FROM ANY and all rights and CLAIMS INCLUDING CLAIMS ARISING FROM THE RELEASED PARTIES' OWN NEGLIGENCE, which I have or which may hereafter accrue to me and from any and all damages which may be sustained by me directly or indirectly in connection with, or arising out of my participation in or association with the Team, or travel to or return from Team events.

I hereby consent to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during Team events.

I have no physical or medical condition which to my knowledge, would endanger others or myself if I participate in this Team, or would interfere with my ability to participate in this Team (except for _____). I agree to wear an ANSI or SNELL approved helmet and to ride in accordance with all applicable laws.

I further understand that while I am wearing the uniform, in full or in part, of the Team, I am their representative and agree to follow the Team Code of Conduct. I will conduct myself in a professional manner, being a credit to myself, the Team and its members. I will follow all rules and regulations as spelled out by the USCF. If I engage in unsuitable behavior, action, or language that brings negative attention to the Team, that incident or series of incidents will be reviewed by the Board. The Board will take action as deemed suitable and their decisions will be abided by me, up to and including my withdrawal from the club.
